## Brief Thoughts About 2022

# Stronger TOGETHER.

**As I reflect on my five years with this amazing organization, I recall the question I was asked during my interview: “Steve, many of our stores are struggling, our volunteer numbers are down, we have a significant debt issue and the cost to open new stores is increasing rapidly. How are you going to turn things around? How will you bring back our volunteer numbers and restore life and vitality to stores that are struggling?”**

My answer was rooted in what I had researched and experienced during my initial store tour. I had witnessed store volunteers and staff pouring out care and love for shoppers. I had experienced the deep appreciation that our receivers expressed for donations – literally hands up high – when a receiver approached my vehicle. They were so authentically grateful for my donation.

I had caught the vision.

Inspired by this vision, I ran out to a store and purchased 10 high-quality washcloths that looked like blankets. During my final interview, I was given an opportunity to speak. I pulled out the washcloths/blankets and shared a fictional story about a single mom who visited one of our stores with her newborn baby. The volunteers and staff warmly welcomed her with a big smile and a friendly embrace.

As the single mom made her way through the store, she was approached by another volunteer who asked if she could help her find anything. The mom replied that she was looking for a blanket for her newborn baby, because their basement apartment was cold. Joyfully, the volunteer led her to the linen section where they searched and found the best warm blankets. The volunteer asked the young mom to put her hand inside the blankets and asked her what she felt. The mom replied that she felt warmth deep within.

## CHIEF EXECUTIVE OFFICER'S REPORT

They loaded her cart with everything she needed and more. The young mom was hesitant and expressed concern that she had little money, but the volunteer assured her that it would be ok. The volunteer led the young mom to the cash register, sharing a knowing look with the manager. The person at the cash register had a big smile and announced that all the items were free of charge. Through tears, the young mom gratefully accepted the desperately needed gifts. Hugs were exchanged all around, and the volunteers and staff assured her that she was always welcome.

That night, the child and young mother slept well.

After sharing this story with our Board Directors, I gave out the blankets and asked them to put their hands over them to feel the warmth. This, I explained, is how we will see a recovery of volunteers, address our debt issue and achieve sustainable growth – by pouring out Jesus' love in our stores every day across our great land and then through the great work of Bible League, in Canada and almost fifty countries around the world. This is how we will achieve unity and bring together our 50+ Mission Thrift Stores with the Foundation to serve in harmony all while increasing our funding support of Bible League.

The board appreciated the analogy and offered me the position, and I have now served this amazing organization for five years. Looking back, I am deeply appreciative of the many friends I have made. I am also deeply moved by the outpouring of love to the local community and around the world. I cannot imagine a better organization doing better work! Our environmental impact is phenomenal, and we have a great impact on our local communities as we provide a fantastic place for people to become friends and to support one another through challenging times. We offer affordable products and, of course, our primary purpose to raise funds for BLC in Canada.

# Board of Directors' Report



## BOARD OF DIRECTORS' REPORT

**The theme for the 2023 Annual General Meeting and our time together is aptly called “Stronger Together”. We have based this on Matthew 18:20 “For when two or three gather in My name, there am I with them.” There have been many “gatherings” over the past year of three or more participants, with most of the meetings being virtual gatherings. We can gauge the Lord’s presence in our work by the tremendous outcomes witnessed this past year.**

**In 2022, we started a new tradition** of having a Board Director contribute an article to the monthly Communique newsletter. This was a great opportunity for us to share on variety of topics within the broader organization. We sincerely hope to continue that tradition going forward.

### **In September, we held a Board meeting and spiritual retreat**

## BOARD OF DIRECTORS' REPORT

Much of our time and attention has been on the Potential Restructure discussion, striving and strategically moving toward our optimal organizational structure.

**A Joint Task Force of BLC and BFM was established** to review the financial stability concerns we had identified as a Board. Support Centre Staff launched a Restructure Advisory Council, made up of Store Board Directors, Store Managers, BFM Staff, the Vice Chair, Doug Moore, and myself. Through legal advisement we have been studying and discussing what a restructure would entail, how this could be accomplished, and more importantly, how this could support and strengthen the organization in all aspects. Our goal is to create a healthy, thriving organization that will achieve our mission goal of contributing \$20 million in funding annually to Bible League Canada by 2030!

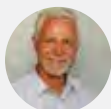
### **Dennis Kerber**

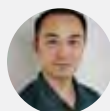
### **Machiel Talsma**

### We are at a time and place where we can look back and see what God has done, and know that He has preserved and continues to grow His kingdom!

Limitations created by the pandemic are on a downward trend. In the early days of the pandemic we did everything possible to preserve ministry capability, so when we returned to full capacity, the ability to do ministry would be intact. God knows what we need.

In the midst of the pandemic, local champions found new ways to reach people, and ministry was able to continue. Differently, moderately, but still continue. God knows what they need.

In the past year, most pandemic restrictions have ended, and a sense of normalcy is returning. We are now able to look back and count the blessings, while looking forward at what needs to be done. Realizing that no capacity for ministry in the field was lost, and assuring ministry partners that funding

for ministry work was back to pre-pandemic levels as of August 31, 2022, is great cause for celebration!

Knowing that in-person ministry is being enhanced and gaining momentum through technology, in countries where previously no technology was being used, is a blessing.

### You Made a Difference!

In the pandemic years of 2020–2022, when **305,073** local champions received vital training and Biblical resources, you were there, with us. And, despite being confronted with ongoing challenges, your faithfulness made it possible for these local champions to share the Gospel message of Jesus Christ with **4,881,697** people, start **20,867** new churches and see **1,835,383** people become new followers of Jesus!

The Word of God, the Bible, is at the heart of all of this, and your support also meant **10,478,104** Bibles, New Testaments, and Scripture portions were placed in the eager, waiting hands of believers hungering for God's Word.

## PRESIDENT'S REPORT

Here are stories from 2 people participating in an adult ministry in Canada:

*"I am Fiona. For two years, I have learned English in an ESL class (English as a Second Language) at a church in my neighbourhood. The ESL material helps me to check my learning progress. We use the Bible for reading practice. There are many interesting Bible stories that I've never heard before. The teachers are all very nice and easy to talk to. I would like to thank the church for providing us with this great learning opportunity, and I will keep working hard on learning English."*



This church in Coquitlam, BC, is in its fourth year offering ESL Programs to their community.

The curriculum is specifically designed and approved as ESL and also incorporates Gospel teaching. The students learn more about the Gospel each week and are introduced to the Bible as they progress in their studies.



The impact of the program is evident as students have demonstrated their growth in learning English, and their understanding in the Bible. The church rejoices with each new follower of Jesus, like Fan:

*"My name is Fan. I have learned English for two years. I have progressed my English. I appreciate my teachers. They gave me a lot of knowledge, and in the process of learning, I also learned more about God as I studied the Bible and learned Bible stories that deeply affected me. I asked to be baptized. I am grateful for learning so much; it was an unforgettable experience."*

Because of your support, and by the grace of God, Bible League Canada's ministry is stronger than ever before. The momentum gained in the past 3 years has provided a solid foundation and clear purpose moving forward, so together we see God's name exalted among the nations! **We are stronger, together!**

## Management's Responsibility for the Summary Financial Statements

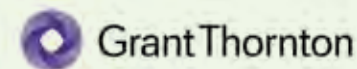

## Note to the Consolidated Summary Financial Statements

### Note 1: Basis of presentation

The summary financial statements are a summary of the financial statements of BFM Foundation (Canada) for the year ended December 31, 2022. These financial statements are summarized in accordance with the following criteria:

- The summary consolidated statement of financial position summarizes assets, liabilities and net assets by attributes;
- The summary statements of operations and changes in net assets summarizes revenues and expenditures by functional categories;
- The summary statement of cash flows summarizes cash flows by type of activity; and
- The notes to the financial statements are included only to the extent necessary as to not make the summary financial statements misleading.
